Three Hundred Eighty Three Thousand, Seven Hundred Seventy One (\$383,771) DOLLARS.


SECTION 2: This Ordinance shall be in full force and effect from and after its


The property taxes extended for debt service and public building commission leases for fiscal year May 1, 2019 through April 30, 2020 were Zero (\$0) Dollars.
